WALK-IN CENTERS WERE ESTABLISHED IN BRYAN-COLLEGE STATION AND STATION SPECIFIC INFORMATION WAS PROVIDED TO THE WALK-IN CENTER. STATION AIRED THE EARLY TERMINATION NOTICE AS REQUIRED. BRAZOS VALLEY FOOD BANK AND TURNER, PIERCE & FULTZ WERE UTILIZED IN THE MARKET TO ACT AS A CLEARING HOUSE FOR DONATED CONVERTER BOX COUPONS, CONVERTER BOXES AS WELL AS OFFERING ASSISTANCE WITH THE INSTALLATION OF THE CONVERTER BOXES.
